Retreat from Monhegan How one patient chose to give back

Gail Edwards, a busy professional from the Bronx in New York City, had been thinking about taking a helicopter ride. Just for fun, to see the country's largest city from a different perspective. She had mentioned the idea to her boyfriend,



dropping a hint for a possible birthday present. An emergency medical helicopter ride in the middle of the night, however, was not what she had in mind.

Gail lives the typically busy life of an urban professional, working as a recruiter for a large education management organization. She had also recently undergone surgery and was hoping a relaxing vacation would be just what she needed to complete her recovery. She was headed to remote Monhegan Island, off the coast of Maine, with her good friend, Deitra Hall, for a knitting and yoga retreat organized by

Suzanne Lynch and Lisa Evans of Knitting and Yoga Adventures. As she made her way up the east coast from New York, she didn't feel quite herself. She had lost her appetite and didn't feel well on the ferry out to the island, although that could have been just a routine case of seasickness.

However, after she arrived on the island, she continued to feel sick. The retreat organizer, Suzanne Lynch, treated her to a massage that helped Gail feel better until the following evening, when she began to experience a lot of pain in her abdomen. So much pain, in fact, that she clearly remembers thinking, "If I don't get off this island, I'm going to die."

Fortunately, Suzanne's husband, Bruce Maslack, was a doctor and, after a quick examination, he recognized Gail needed immediate medical attention that wasn't available on the island. He called for Life-Flight of Maine shortly before 9:00 pm and had a detailed phone consultation with Dr. Kevin Kendall, one of LifeFlight's medical directors. Based on her symptoms and previous medical history, the physicians believed Gail had a possible small bowel obstruction, a condition that can only be treated with surgery. Since there was no way off the island until the following morning, Dr. Kendall dispatched the LifeFlight helicopter to meet the patient on the island's baseball field. Bangor-based crew members John Marino, pilot; Kim Savage, flight nurse; and Carl Zenk, flight medic arrived on Monhegan less than 45 minutes after the first call for help.



"The crew was very comforting, wiping my forehead and telling me everything was going to be alright," recalls Gail.

She was given medication to help with her pain and loaded into the helicopter for the short 20 minute flight over to Central Maine Medical Center in Lewiston. Dr. Kendall had a team ready for her arrival, but she was so severely dehydrated, he needed to postpone the surgery a few hours until Gail had stabilized. The surgery went smoothly and Gail spent nine days recovering in the hospital. It would be eight long weeks before she could return to work on a part-time basis.

Back to work in New York, Gail often found herself thinking about her island experience and how fortunate she was that she was able to get to a hospital where specialists could help her. "While onboard the helicopter, I remember thinking how expensive this service must be, but how grateful I was that it was available. I knew I wanted to support LifeFlight once I got back on my feet, to help ensure it would be there for others who need it."

Which is exactly what she did. As a non-profit organization, LifeFlight depends on private donations to help ensure the service will be available to every Maine resident, 24 hours a day, 7 days a week. We send a heartfelt thanks to Gail and all of the other donors like her, who recognized the need for LifeFlight and made the decision to support it.

Comprehensive Care on Maine's Islands LifeFlight Teams Up with Maine Sea Coast Mission

LifeFlight recently partnered with the Maine Sea Coast Mission for a presentation on Isle au Haut, one of the many islands off the coast that receives preventive and emergency healthcare from both organizations. The presentation highlighted the services available to island residents, including telemedicine, healthcare screenings and emergency medical services.

Island residents had an opportunity to tour both the LifeFlight helicopter and the Sea Coast Mission's boat, the *Sunbeam V*. They also met Sharon Daley, nurse onboard the *Sunbeam*; Dr. Scott Schiff-Slater, physician in Hallowell who assists patients through telemedicine; Diane Barter, EMT on Isle au Haut; and LifeFlight crew members.

LifeFlight and the Maine Sea Coast Mission provide complementary healthcare services to Maine's islands. Residents count on critical and emergency medical care from LifeFlight; and health clinics, education and personalized care from the Maine Sea Coast Mission.

Mobile Hands-On Training Available by Request

The Human Patient Simulator program, owned by Maine EMS and operated by LifeFlight of Maine, will be traveling across the state again this year, bringing advanced medical training directly to rural communities in Maine. This mobile training lab features a life-size mannequin capable of breathing, talking and reacting to healthcare provider interventions. Through this program, facilitators from LifeFlight are able to provide a unique, hands-on experience fully customized to meet the medical education needs of any hospital, EMS service or educational institution.

Education and scenarios are constructed to meet practitioners needs and can include:

- Didactic/Practical education
- Integration into certification classes like ATLS, PALS, TNCC and PHTLS
- Customized scenarios
- EMS-specific topics
- · Physician-specific topics

The RV-housed simulator lab brings high quality, hands-on education directly to your home area. The state-of-the-art HPS mannequins (adult, pediatric, infant) simulate a lifelike patient who will improve or deteriorate based on treatment by the practitioner. Programs offer CEUs for nurses and respiratory therapists, CEHs for paramedics, and Category 1 CMEs for physicians and mid-levels. The HPS is facilitated by Lifeflight nurses and paramedics with statewide physician oversight to ensure best practice teaching points.



LifeFlight of Maine is a nonprofit statewide critical care medical helicopter service jointly owned by Eastern Maine Healthcare Systems and Central Maine Healthcare Corporation. LifeFlight's two helicopters, based in Bangor and Lewiston, cover the entire state and offshore islands. LifeFlight complements and supports the work of local EMS and hospital personnel in caring for the critically ill or injured. Each base is staffed by a highly qualified team of pilots, mechanics, flight nurses and paramedics. More than 8,000 patients have been safely flown since LifeFlight's founding in 1998.

LifeFlight is fully accredited by the **Commission on Accreditation of Medical** Transport Systems.
